

FERC Workshop/Trans-Atlantic Infraday (TAI) 7-8 November 2013

Dear Colleague: We are happy to announce two energy events for 2013:

- <u>Thursday Nov. 7, 2013</u>: Federal Energy Regulatory Commission (FERC, <u>www.ferc.gov</u>) <u>Workshop</u> on "New Methods and Models for Improving the Efficiency of Power Grid Operations and Planning: Dealing with Nonconvexities and Variable Renewables".
- Friday November 8, 2013: Trans-Atlantic Infraday 2013 Conference on all aspects of energy markets, for example engineering/economic models to analyze: Natural gas, oil, power, coal markets, food and energy, energy and transportation, renewable energy, Smart Grid applications, investments/operations in several energy markets

Note:

- 1. The FERC workshop will be a specialized meeting with talks concentrating on the topic above. This is the same as in previous years with just a change of theme (no charge).
- 2. Unlike the past six years, the Trans-Atlantic Infraday (TAI) this year will also be at FERC and will be free of charge.
- 3. Also different from previous years, the TAI Conference (8 November) will only be on energy topics with an infrastructure connection. This is still fairly general and several examples are mentioned above.
- 4. Also unlike previous years, <u>food will be paid directly by the attendees</u>. FERC has several cafeterias in house and there are a number of restaurants in the vicinity as well.
- 5. There is an optional dinner Friday night for \$45 per person.
- 6. Registration for the FERC workshop (Nov. 7), the TAI 2013 (Nov.8), and the optional dinner (night of Nov. 8) must be done on **www.regonline.com/TAI2013**. The reason is that for the two meetings on Nov. 7 & 8, we need to have the names of the participants ahead of time to allow them to enter FERC.
